Global News

13th Special Session of the Human Rights Council on Haiti

The Council adopted a resolution, which includes a reference to persons with disabilities. IDA delivered a short statement and requested that the Human Rights Council include persons with disabilities in this resolution. Fourth session of the Advisory Committee (January 25-29)

IDA had submitted a contribution to this session, which included the proposal to add a specific reference to persons with disabilities in the draft declaration on human rights education and training being prepared by the Advisory Committee. During this session, IDA made a short statement based on the written contribution. Finally, the revised declaration includes a reference to persons with disabilities in the paragraph 7 of the Annex. • CRPD Ratifications reach 79

The ratifications of the CRPD in February by Ukraine and Zambia have increased to 79 the number of States Parties to the CRPD. Ratification by Ukraine and Nicaragua of the Optional Protocol (OP) increased to 50 the number of the States Parties to the OP. The signature of the OP by Latvia increases to 88 the number of signatures to the OP, while the Convention has 144 signatures.

Treaty Bodies

• The 45th session of the CEDAW Committee took place from January 18 to February 5 in Geneva. The Committee held two sessions with NGOs: Monday, January 18, for Uzbekistan, Ukraine and Malawi and Monday, January 25, for UAE, Netherlands, Egypt, Botswana and Panama.

The IDA Secretariat presented on Monday, January 25, its work to mainstream the rights of persons with disabilities in all treaty

bodies. Based on the analysis made of the State reports under review in this session, IDA highlighted the little attention given to the rights of women with disabilities by States in their reports and gave some examples on how the Committee could increase and improve the attention of States to the rights of women with disabilities in the future. IDA has also made proposals for concluding observations and lists of issues, which were uploaded on the CEDAW website.

• The CRC Committee, in its 53rd session, considered from January 11-29 reports from Burkina Faso, Cameroon, Ecuador, El Salvador, Norway, Mongolia, Paraguay and Tajikistan. OPSC: Ecuador; El Salvador; Estonia; Mongolia and Sierra Leone. OPAC: Ecuador; Israel; Liechtenstein; Mongolia and Sierra Leone. Upcoming Session of the Human Rights Council

The 13th session of the Human Rights Council will take place from March 1-26, in Geneva. IDA has undertaken a disability analysis of the reports that have been prepared for the 13th session of the Council.

The following Special Procedures reports, which have been presented to the 13th session of the Human Rights Council, include references to persons with disabilities: Special Rapporteur on adequate housing; Representative of the Secretary-General on the human rights of internally displaced persons; Independent Expert on minority issues; Working Group on arbitrary detention; Working Group on involuntary disappearances; Special Rapporteur on the right to food and Special Rapporteur on Torture. Upcoming Meetings

The 3rd session of the CRPD **Committee** will take place from February 22-26, in Geneva. The draft agenda and programme of work for this session are now available on the CRPD Committee website. Most of the meetings of the Committee are planned to be closed and will focus on finalising rules of procedure and working methods. The Committee will also discuss follow-up issues related to the day of general discussion on Article 12 (including the option to draft a General Comment on Article 12) as well as plans for a day of general discussion to be held at the fourth session of the CRPD Committee. IDA has invited all members of the CRPD Committee to a joint meeting in the afternoon of Sunday, February 21, the day before the CRPD Committee will meet.
